A registration fee of five hundred dollars (\$500) must accompany this application and applies in all cases. This fee is in addition to the tuition, which must be paid before April 1st, 2010. Please see separate rate chart. Payment of tuition may be made by check drawn on a bank in the USA, credit card, or wire transfer directly to our bank account. Tuition is not refundable if a camper is withdrawn after April 1st. Partial refunds are not given if parents withdraw a child early during camp or if a child is asked to leave due to a violation of the behavioral contract. All campers and parents are expected to adhere to the standards of behavior set forth in the Robin Hood behavior code and parental guidelines; failure to do so may result in dismissal from camp. The right is reserved to dismiss any child from camp if it deemed advisable for the good of the camp, without assigning a specific reason.
